CURRENT FINANCIAL STATUS

- Church Offerings are down \$24,000 compared to last year and the reserve account is nearly depleted which makes it difficult to maintain a consistent cash flow without having to tap into a Line of Credit loan.
- Debt Reduction & Capital Improvement fund is almost depleted. The fund is used to pay Life mortgage and outlot fees.
- Voters will be asked to prayerfully consider their current unified budget giving. Also, a request will be presented to launch pledge drive to replenish reserve account and pay down Life mortgage debt.
